Enclosed please find a sample of the ballot to be used in the election to fill the Offices of President, Vice President, Recording Secretary, Business Manager/Financial Secretary Treasurer, Assistant Business Manager, Business Agent, Business Representative/Organizer, Inside Guard, Executive Board (4 members), Examining Board (5 members), Finance Committee (3 members), all are 3 year terms. Medical Trustee, Pension Trustee, Retirement Savings Plan Trustee, all are 6 year terms. 1 Pension Trustee (who will serve for a three year term). The length of the Pension Term will be based on the number of votes, the highest voting numbers will be the six year term with the 2<sup>nd</sup> highest receiving the 3 year term. The election will be held on Monday June 1, 2015, from 12:00 p.m. to 6:30 p.m., at the UA Mechanical Trades School, 8509 Ardwick Ardmore Road, Landover, MD 20785.

In the event of a tie, a run off election shall be conducted among those candidates at the U.A. Mechanical Trades School on Saturday, June 6, 2015 from 12-4 p.m.

All results will be announced at the June, 2015 Regular Union Meeting, to be held on Tuesday, June 2, 2015 at 5:30 p.m. at the UA Mechanical Trades School, 8509 Ardwick Ardmore Road, Landover, MD 20785.

### Eligibility to Vote at Local Union Election

#### **Sec 124, page 86 from the Constitution of the United Association**

- (a) No member shall vote at any election of any description unless he has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of the election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of the election shall not be eligible to vote in any Local Union election.
